Update on the National Coalition on Dual Diagnosis

NADD Ontario is one of four original sponsors of the National Coalition, partnering with the Canadian Association for Research and Education in Intellectual Disabilities (CARE – ID/ACREDI), the Developmental Disabilities section of the Canadian Psychiatric Association, and the Dual Diagnosis Program, Centre for Addiction and Mental Health.

This is the first time in Canada that we have a **common definition of dual diagnosis** and a set of recommendations for the National Mental Health Commission

of Canada to include in the development of the National Mental Health Strategy.

The recommendations and accompanying **Advocacy Toolkit** were developed by families, child, youth and adult service providers, researchers and academics from the developmental, health and education sectors from 7 provinces across Canada. The NADD Conference in Niagara Falls will mark the official launch of the growing coalition. The recommendations and Toolkit were also presented in BC and Manitoba

this fall, galvanizing local communities to take up the cause. The web based Toolkit includes a FAQ's sheet, Pamphlet, Glossary, Fact sheet and real stories that can be used by local and provincial groups to tell their story and advocate for change.

Update on Recruitment and Retention—the Ontario Developmental Services Sector Human Resource Strategy

This initiative is co-sponsored by the Provincial Network on Developmental Disabilities and the Ministry of Community and Social Services. As we described in our Spring newsletter, NADD Ontario is represented on the various committees that have been established. The Core Competencies committee is the first one to have met and has been supporting the Hay Group to run focus groups across the province with front line staff.

The purpose of the focus groups is to understand the context in which participants do their job, the key

accountabilities of the job, the important/critical tasks and outcomes of outstanding performance, and identify the core competencies for each of the roles. A competency is 'an underlying characteristic... which enables a person to deliver superior performance in a given job, role or situation'. (Hay Group) In this approach one is more interested in the core underlying elements of social role, self image, traits and motives required to perform effectively in a job, on the assumption that skills and knowledge can be learned and developed.

NADD Ontario is pleased to report that because of our involvement, the focus groups were expanded to include a session with Clinical Staff who work in the developmental sector and are in positions that are funded by the Ministry of Community and Social Services. This includes nursing, speech and language, psychology and behaviour therapists. The basis for this change is that all front line staff in the sector provide supports and services to individuals with dual diagnosis/ challenging behaviour/complex needs and the competences required

Update on NADD Ontario's book - Dual Diagnosis: An introduction to the mental health needs of persons with developmental disabilities (2002)

The North Community Network of Specialized Care used the first four chapters of the NADD text to develop an E-Learning course. The learning module topics include a basic introduction to the nature of developmental disabilities, recognizing and understanding the mental health needs of persons with developmental disabilities within a bi-opsychosocial model, and implications and strategies for optimizing supports. Learners are also introduced to the criteria used by health care professionals to recognize and differentiate various psychiatric conditions.

Piloted in 2008, 70 staff (61% front line) from 23 agencies across the North successfully completed the four modules. Seventy-six percent of respondents advised that they had never taken web-based training before. Ninety-four percent stated that the online format was a good way in which to learn this material, and another ninety percent stated they would take another online course. Learners enjoyed the flexibility in accessing the course anytime and anywhere. One learner commented "It made me really think about how I support people and learned some new skills to do things differently." Another stated "This online course will definitely benefit those of us in outlying communities that don't always have other options."

NADD Ontario Chapter Recognition Award - Call for Nominations

Deadline for nominations is February 15, 2009. The award will be announced at the Spring Annual General Meet-
