NADD, Ontario remains a very vibrant chapter of the National Association of Dual Diagnosis (NADD). You will note in this current newsletter that the Board is actively reviewing ways in which it can enhance the organization's role as an information and education resource to promote understanding of dual diagnosis.

The need for more coordinated efforts to improve services and funding for individuals ith a dual diagnosis is more evident now then ever before. With the announcement of

with a dual diagnosis is more evident now then ever before. With the announcement of the closure of three remaining institutions (for those with Developmental Disabilities) in the Province and the continuing growth of need within the community, the requirement for more services is even greater. The Minister of Community and Social Services has just announced an investment of \$41.1 million to

strengthen services for adults with a developmental disability. The Minister said "We are taking a bold new approach in our transformation of developmental services". Most importantly she also emphasized:

### "...we want to hear what is happening in your communities..."

"This is part of our plan to improve access to services for Ontarians with a developmental disability no matter where they live". The plan appears wide-ranging and inclusive. However, it is imperative that as professionals, service providers and families we must continue to work toward enhancing services as well as the knowledge base from which these are provided.

I once again invite our members to participate actively. We need input from families, direct service providers, professionals on how we can insure that the needs of this population remains a priority. Please send your feedback regarding the bulletin, the web site, or other publications to our Editor Susan Morris or any member of the Board. Also, we want to hear what is happening in your communities and share your successes with others. Best wishes for the summer!

## Consumer and Family Support Local Committee Update

On January 18, 2005 the inaugural meeting of the South Eastern Ontario Regional Dual Diagnosis Advisory Committee was held. The committee's vision is to create an interdependent system of shared care for individuals with both a developmental disability and a mental disorder throughout South Eastern Ontario focused on providing access to medical care, mental health, addictions and support services. The intention of the committee is to build on and support a practical change in day-to-day supports to individuals with a dual diagnosis. The committee will work to improve cooperation, co-ordination and sharing of expertise. The "key issue" identified is the reality that the service and support system is overextended with high demand and complex needs.

By sharing expertise the regional committee will:

• Build regional working relationships and recommend the development of service agreements in accordance with the 1997 Policy guideline: The Provision of Services for Persons with a Dual Diagnosis

- Contribute to communication among partners in the region regarding availability of existing services, mandates, trends, and service pressures
- Develop a template for protocols for use by local community service providers (i.e. in each two county area) in describing arrangements for the provision of normal day-to-day services and when an individual with a dual diagnosis is in crisis
- Support the development of protocols regarding any types of services or situations that may benefit from clarity in arrangements
- Ensure that the protocol/process will be reviewed and updated to respond to changes in systems, resources and the overall environment
- Provide a forum for the sharing of information on evidence based practices and service gaps and proactively advocate for ongoing improvements to collaboration and services
- Gather and disseminate information regarding needed training, new initiatives, and utilization of current resources in the district/region.
- Promote the development of research within the district/region which is deemed likely to contribute to evidence based practices
- Create an index (database) of resources to assist us to work across systems

Co-chairing the committee are Bob Cunningham, Executive Director, Mental Health Services- Hastings Prince Edward and Geoff McMullen, Executive Director Developmental Services of Leeds and Grenville. Committee members include representation from the range of children and adult community mental health providers, developmental service providers, corrections, the psychiatric hospital and University. ## **Interministerial News**

An unprecedented convergence of opportunities is occurring in Ontario for Dual Diagnosis! The Ministry of Health and Long Term Care has begun investments in the mental health sector that focus on reducing the need for hospitali-

zation. The goal of the current government is to invest an additional total of \$185 million by 2007-08. The funding priorities are intensive case management, crisis response, early

intervention psychosis, Assertive Community Treatment and supportive housing. Additionally \$27 million was announced this winter under the Forensic Service Enhancement Strategy in an effort to limit the number of mentally ill persons (including individuals with a dual diagnosis) entering the criminal justice and correctional systems. Service expansion is focused on building a system of crisis response/outreach, short-term residential crisis support beds, supportive housing, court support services and intensive case management services.

At the same time the Developmental Sector is about to release the next policy document for consultation related to transformation of that sector. Additionally

a recent announcement occurred regarding investment of \$41.1 million into training, specialized care and housing for individuals who have very high needs as a result of mental health issues and/or challenging behaviours.

This is the ideal time for local dual diagnosis committees to provide leadership in facilitating and supporting collaboration between the developmental sector structures (e.g. residential service committees and service resolution processes) and housing committees and specialized multidisciplinary teams in the mental health sector. It's an opportunity to forge creative solutions that build on the strengths of both sectors and to address longstanding gaps!

## **A Partnership in Action**

Central East Region (Simcoe, York, Durham and Haliburton, Kawartha Pine Ridge) has a new specialized resource to support persons with exceptionally high levels of need. **The Pineview Project** consists of three components. The **Transitional Residential Treatment Home** is a 5bed short-term (maximum 12 months) treatment program located on the grounds of the Mental Health Centre Penetanguishene and is managed by Community Living Huronia. **Community Capacity Building** includes training to support local communities to work with people with a dual diagnosis.

The **Mobile Resource Team** was developed to prevent hospitalization and admission to the Transitional Residential Treatment Home by offering support to community teams. The multidisciplinary team includes participation from the Pineview Treatment Home, York Simcoe Behaviour Management Services, Penetanguishine Mental Health Centre Dual Diagnosis Program, Community Living Huronia, Catulpa Community Support Services, Kerry's Place Autism Services, Access Community Services, Canadian Mental Health Association and Whitby Mental Health Centre. Functions of the team include meeting with the individual referred and his/her community team, reviewing current supports and treatment plans, providing suggestions as to connections with community resources, using an individualized approach to make recommendations for the person to remain in the community, perhaps with additional supports as required, admission to the treatment home, or hospitalization. To date, the Mobile Resource Team has had 15 inquiries, completed 9 intakes and provided community home support for 4 individuals. initial decisions include discontinuation of hard copy versions and subscriptions to the newsletter and integration of the newsletter onto the website. The Communication Committee will develop a process for electronic notification of the updated newsletter available on the web, and undertake more frequent updating of web pages. The Education Committee is discussing the feasibility of e-learning and web-based training, as well as re-working parts of the dual diagnosis training book to provide practical suggestions and

strategies for families and caregivers. In our Fall newsletter, posted on the web, we will publish our updated vision and goal statements and

provide more information on the activities of each committee.

# Here & There

The Standing Senate Committee on Social Affairs, Science and Technology is conducting an online consultation to provide citizens with the opportunity to express their views on the options for transforming the mental health, mental illness and addiction system that are currently being considered by the Committee. The online consultation will run from April 11, 2005 to June 6, 2005. There are two ways to participate in this online consultation: consultation workbook presents various scenarios and alternatives for consideration, as well an opportunity to set priorities for action; and an ideas and recommendations section allows participants to make suggestions for the committee to consider. A Caregiver Online Consultation sponsored by Social Development Canada can be accessed from Social Development Canada's website at www.sdc.gc.ca. May 4, 2005, to June 30, 2005. (Click on Consultations). Their focus at this time is on family/unpaid caregivers. They want to learn more about the experiences of caregivers and to hear about the priorities of caregivers, care receivers, and Canadians. They want to hear particularly from family/unpaid caregivers and their care receivers. There are two ways to participate: one is through a stories and ideas area, and the other is by completing an online consultation workbook.

Federal Rent Supplements to Improve Access to Affordable Housing was announced by the by Federal Housing Minister Joe Fontana on March 23, 2005. Approximately \$150 million is to be used for rent supplements in Ontario to support low-income individuals in affordable housing. The funding was originally to be cost shared with the provincial governments. Because of limited provincial involvement in the program, only \$65 million of the budgeted \$366 million was spent. The program has been changed to allow half of the remaining amount to be used in rent supplements without matching provincial support. The funding

depends on a signed agreement between the provincial and federal governments. One-third of the funding will likely be directed to people living in Toronto, and will be directed to low-income seniors, people with disabilities and new Canadians. **Fifty-two Family Health Teams** were announced on April 15, 2005 by the Ontario Ministry of Health and Long-Term Care. The goal is to serve over one million Ontarians through a total of 150 teams by 2007-2008. Family health teams are interdisciplinary groups of health care professionals, including doctors, nurses, nurse practitioners, social workers and other health care professionals, who will provide primary health care in a collaborative setting.
